# Meri Squares President's Report, 2024-2025

Meri Squares is functioning well, both socially and financially. At a time when a number of Ottawa area square dance clubs are ceasing to operate, our club is increasing its membership and achieving better than break even budgets.

Our introduction of Social Square Dancing (SSD) three years ago has been a definite success; we now have four squares dancing, sometimes five (including angels) on Tuesday evenings, and by the end of this season we will have introduced and graduated 22 new dancers to square dancing in the past year, a total of 60 over the three years! We recently introduced dance step coaching for our SSD students in the half hour before the regular dance, and this has proven very popular. Our Plus dancing on Thursday evenings, however, has reduced to two squares, sometimes three, as some dancers have dropped away from the activity. We are hoping to reverse this trend by offering a Plus teach over the Fall 2025 and Winter 2026 sessions.

Meri Squares is clearly one of the leading and trend setting clubs in the Ottawa area, and one of only three clubs that dance on more than one night per week. In addition to our regular weekly dances, we host and organize special events that are well attended outside of the club, such as the Meri Mingle Plus dance in February, 2025. As well, we hold demonstration squares from time to time when requested by outside organizations, typically retirement homes, which provide fun and square dance awareness to an outside audience. All of these activities receive support not only from the Executive but also from regular dancers, a number of whom regularly volunteer in such tasks as chair and table set up and take down, food preparation, provision of snacks and manning of registration tables. Meri Squares provides major services to the local community – beyond the good times and the mental and physical recreation of our activities, we also contribute substantially to local charities including the Snowsuit Fund, the In From the Cold charity for homeless residents, and the local food bank.

In 2024 we launched a brand new website for our organization. This was a major effort spearheaded by Guy Quesnel and Gerry Lelievre, with assistance from Michelle Gravelle, Jacques Chesnais and myself. We developed the website over the summer of 2024 based on a template provided by Jean-Marc Robichaud of Ottawa Date Squares. The site launched in August in time for our new fall dance season and is a great improvement in the online look and feel for our club. The Meri Squares Executive team deserves recognition for their work behind the scenes managing the club. Team members are both competent and dedicated, and a number deserve special mention for having served for a significant number of years – Gerry Lelievre (treasurer), Colleen McEwan (membership), Michelle Gravelle (secretary) and Pat McLachlan and Jaques Chesnais (publicity, and

vice president). You may recall that at the AGM two years ago we created a special "member at large" Executive position because we had no representation from our SSD dancers, and Lynn Wilson joined the team in this capacity. Well, our new slate of candidates for our Executive team contains no less than five from our SSD group; this excellent participation from our newer dancers has brought balance to our Executive between our two major activities.

Weather was not kind to us this winter; we ended up cancelling four Plus dances and one SSD dance, which is the most of any year in my recollection. Makeup dances have been scheduled which will extend our dance season to the end of April for SSD and into May for Plus. As in the previous two years, we plan to offer monthly dances over the summer with alternating SSD and Plus level tips.

I want to end this report by thanking all of our member dancers, our volunteers, our Executive team and our callers. Together, you have built a happy, successful club that contributes to the health and wellbeing of its members and to the effective functioning of the wider Ottawa community. It has been a privilege to serve as your President over the past two years.

# 2025 AGM Membership Report

Meri Squares is a large active square dancing Club in Ottawa consisting of two groups of enthusiastic individuals – SSD and Plus.

Our membership indicates that there are 38 SSD dancers and 32 Plus members but not all dancers participate on a weekly basis.

Every Tuesday SSD meet at Dulude Arena, 941 Clyde Avenue, while the Plus dancers attend at Westminster Presbyterian Church, 470 Roosevelt Avenue on Thursdays.

Membership fees are paid either by the session or nightly with the following results

SSD: Session 25 Nightly 9 PLUS: Session 21 Nightly 8

These totals are based on weekly attendance from the winter session. There are usually four complete squares on Tuesday while Thursday has two complete squares and a few extras.

On Tuesday there is a faithful group of "Angels" (plus dancers) who enjoy participating and assisting new dancers to perfect the newly acquired skills. This explains the larger number of squares in comparison to Thursday's group.

In December '24 there were 11 SSD graduates with some who continued to participate in the winter session. There are 11 new dancers expected to graduate and receive their Meri Square badge at the end of April.

SSD membership has continued to increase this year because of individual participation ability and enjoyment in physical activity. However enrollment of plus dancers has decreased somewhat due to illness and personal physical injury.

Our callers, Wendy VanderMeulen for SSD and John Charman for the Plus group, continue to encourage and challenge us during our weekly program. Meri Squares continues to welcome new dancers and visiting dancers from area clubs at all our weekly programs plus any special planned events

Book Sales Final Report – 2024-25 Dance Year – Final Update Includes Post-Season to 2025 May 22

This is the final report for the 2024-25 Dance Year; up to the reporting date; that is the period – 2024 Sep 19 through 2025 May 22. Sales are conducted at most Thursday dance sessions (some special dances such as Halloween are excluded). Therefore, this report covers 27 evening sessions, including 3 evenings post the scheduled year. This activity of receiving and selling donated books was first initiated on Thursday 2024 Mar 07, with reports issued periodically each year (including prior to the year-end meeting, and after final dance of the dance year).

As at this year's reporting date (shown above), the cumulative period profits (as turned over to the Treasurer) were \$124.30; and the remaining inventory of 33 books (24 Paper Backs, 9 Hard Cover), along with the Payment Jar containing the \$10 Float, and the instruction sign were placed in the storage box in the club locker.

During Thursday dances, the books and instruction/price sign are placed on a table in the dance hall, along with the "payment collection jar", which contains a float that can be used for making change as well as receiving payments. The process is then conducted as a "self-serve" process; with donors adding books to the display, and buyers making payments into the collection jar; and if necessary, making their own change from the float in the jar. The float is \$10 (in \$1 and \$2 coins). This is a trust system with no monitoring, nor recording of the number of books donated or sold. The only records are of the number of books remaining at the end of the evening, and the amount of profit received. The nightly profit is turned over to the Treasurer at the end of each evening. Also, at the end of each evening the books and payment jar (with the \$10 float), and instruction sign are placed in a folding storage box, which is stored in the storage room, in the Club's locked lower right cabinet. Books that go unsold for an extended period are removed and donated to a charity that takes used books.

If needed the person in charge brings \$1 coins to the next week's session to exchange for any larger coins or bills that were left to make up the \$10 float of \$1/\$2 coins. I donated the payment jar, float change, folding case, and sign. The sign, which is also kept with the books, explains the process to potential donors and buyers. This sign also gives the book prices; which currently is Paper Back Books - \$1 each or \$2 for three, and Hard Cover Books \$2 each or \$5 for three.
